If your application is successful an invoice for the appropriate subscription fee will be issued to you. If your application is unsuccessful you will be contacted directly and given an explanation with regard to Publishing Ireland membership criteria. In such circumstances, you may be offered Publishing Ireland Associate Membership.

### **To qualify for full membership you must be:**

- Actively publishing, that is, publishing a minimum of two titles per calendar year - these minimum two titles must be written by an author other than an employee of the publisher, including the publisher themselves
- The publisher must have undertaken the financial risk associated with the publication of the two minimum titles
- Actively offering the minimum two titles for sale
- Trading for more than one year

Full Members are expected both to adhere to Publishing Ireland's [Code of Practice](#) which can be found on the association's website and to take part in Publishing Ireland's biennial trade survey. Participating in the survey provides essential statistical information which aids the association in lobbying on your behalf on both a national and international level.
